#### Progress Report Decisions Made and/or Actions Taken

- 1. In rebuilding requirements at the area level for the last five years, Edison will delete all area detail requirements back to the term code 200810 and then update the requirements going forward through 201210.
- 2. Because the Course Catalog uses terms such as "Accounting related" or "Business related" as opposed to subject codes such as ACG or GEB for the Business Administration and Management program electives, the decisions was made to enter all business related subject codes with a course range as opposed to specific courses in SMAAREA for the electives requirement. In this case, if departments create courses after the catalog term for which the requirements are created, they will still be used by compliance.
- 3. Most of Edison's program should be maintained as Captive programs.
- 4. Edison has one to one correlations between the programs and majors in their curriculum rules; therefore most of their associate degree programs will be Captive.
- 5. Edison will use the AA General Education area for all of their Bachelor degree programs since the requirements are identical.
- 6. Due to the amount of credit hours required in the specific programs, it was determined that the Free Elective area was not needed for the following programs:
- AS Business Administration and Management
- AS Accounting
- AS Para Legal
- 7. Edison has replaced many of the specific courses in their electives areas with ranges of courses based on subject codes and course numbers.
- 8. Edison has added an Eliminate and an Add value to the Student Adjustment Action validation table, STVACTN.
- 9. In the case where the requirement is represented by a range of courses, Edison will need to execute substitution student adjustments in SMASARA instead of SMASADJ.

#### Progress Report Decisions Made and/or Actions Taken

- 1. In rebuilding requirements at the area level for the last five years, Edison will delete all area detail requirements back to the term code 200810 and then update the requirements going forward through 201210.
- 2. Because the Course Catalog uses terms such as "Accounting related" or "Business related" as opposed to subject codes such as ACG or GEB for the Business Administration and Management program electives, the decisions was made to enter all business related subject codes with a course range as opposed to specific courses in SMAAREA for the electives requirement. In this case, if departments create courses after the catalog term for which the requirements are created, they will still be used by compliance.
- 3. Most of Edison's program should be maintained as Captive programs.
- 4. Edison has one to one correlations between the programs and majors in their curriculum rules; therefore most of their associate degree programs will be Captive.
- 5. Edison will use the AA General Education area for all of their Bachelor degree programs since the requirements are identical.
- 6. Due to the amount of credit hours required in the specific programs, it was determined that the Free Elective area was not needed for the following programs:
- AS Business Administration and Management
- AS Accounting
- AS Para Legal
- 7. Edison has replaced many of the specific courses in their electives areas with ranges of courses based on subject codes and course numbers.
- 8. Edison has added an Eliminate and an Add value to the Student Adjustment Action validation table, STVACTN.
- 9. In the case where the requirement is represented by a range of courses, Edison will need to execute substitution student adjustments in SMASARA instead of SMASADJ.
- 10. The general education communications composition rule will need to be designed without sets and subsets as well as minimum required hours for the 1320, 1670 and 2061 in order to get compliance to use the courses when 1101 and 1102 are transferred from a quarter term college.

- 11. For the fall 2008 academic year, the Criminal Justice Career Electives area is designed with two rules representing the Academic Bridge and the Crime Scene Investigation concentrations.
- 12. The Criminal Justice Elective area has been removed from the program for the fall 2008 academic year.
- 13. Because the three options in which students in the Drafting and Design program can concentrate are not identified on the general student record, the requirements for options are created as groups. These groups are attached to an area with same set different subset relationship. Also, all three groups use a "Both" reuse indicator for courses that will satisfy requirements for more than one group.
- 14. Currently, The Paramedic Certificate program has two separate values in SMAPRLE and two curriculum rules in SOACURR. For Admissions purposes, one of the curriculums is stopped as of the term code, 201010. The other curriculum started before the 201010nterm code. Due to this, both programs will need to co-exist for a certain amount of terms. While these programs co-exist, the requirements should be exactly the same for both since students could have either the EMTP or EMST major code. Requirements should not be designed in Degree Works for the EMTP major code as no new students should be admitted with that curriculum.
- 15. On occasion, a department will include a new course to a set of program requirements before it is approved by the Florida State Board of Education. Once the course is approved by the state, the college may need to change either the subject code or the course number. These changes will need to be maintained in CAPP.
