As a grant program funded through the U.S Department of Education(ED) there are 4 objectives written into our grant which we are required to meet each year and that are evaluated by ED from the information we submit on our Annual Performance Report. Below are the objectives how each is measured and the results

Objective 1 Administrative Requirements for Number Served Outcome to be measured

200 SSS participants who meet federal guidelines for program participation will be served each year. All participants must be either low-income (LI), first-generation(FG) or disabled. A minimum of 66% will be both low-income and first generation. 33% of disabled participants will be low-income, and all participants will demonstrate a need for support services. The remaining participants may be either low-income, first-generation and /or disabled.

Measured by

During the SSS application process, students provide information to support first – generation, low-income, disabled criteria. Once eligibility is determined, information is coded, as specified by ED and entered into MS Access Data base used to maintain SSS participant records. The information is then pulled from the database, to complete the Annual Performance Report submitted to ED.

Expected Results

We expected to serve 200 eligible participants annually with 67% or more being both low-income and first-generation, and 33% of students admitted as disabled being also low-income.

With the beginning of this new grant period 2010-2015 the objective has changed to 4 years instead of 3 and with the addition of bachelor degree programs at ESC we are hoping to increase this to a 45% rate so we are looking for ways to improve this statistic. We would like for all our students to be enrolled in bachelor degree programs within 4 years of enrolling in our program.
