## Telecommunication Technology Introduction to Premises Cabling



This course covers information and other low-voltage inside wiring techniques and principles. Also covered are different types of cable and wire associated with these systems along with the National Electrical Code (NEC) requirements. This course is designed for students interested in the physical aspects of voice and data network and cabling installation. This course focuses on cabling issues related to data and voice connections and provides an understanding of the industry and its worldwide standards, types of media and cabling, physical and logical networks, as well as signal transmission. Students will develop skills in cable termination with both jacks and punch blocks, reading network design documentation, pulling and mounting cable, cable management, cable labeling, setting up telecommunications rooms, and patch panel installations and termination, as well as basic cable testing and troubleshooting, and basic cabling calculations. This hands-on, lab-oriented course stresses documentation, design, and installation issues, as well as laboratory safety, on-the-job safety, and working effectively with others.

**Learning Outcome:** Upon completion of classroom work the students will begin a 4 week, 'On the Job Training Program'. Based on a 40 hour work week, the students will be positioned in the work force to initiate their transition into the telecom industry; utilizing, on-site, their newly acquired skills.
