8. Background Information: A formal solicitation, Request for Qualifications, was prepared and advertised in order to Prequalify General Contractors for Calendar Year 2023. An Evaluation Team was formed consisting of the following individuals: Dianne Tredway (had to drop out at the last minute), Tatsiana Shumskaya, Amber Evans and Lori Welch. A total of 25 vendors submitted prequalification applications on 9/21/22. As a result, 24 vendors have been recommended for prequalification status for calendar year 2023. One vendor did not submit sufficient information in order to determine their individual contractor maximum dollar limits for projects (3 sections of the RFQ were omitted from the original submittal & all copies submitted). 6 vendors from CY 2022 prequalification did not submit applications again for CY 2023, however, 4 new vendors did submit applications. Overall, the College typically receives anywhere from 22-38 applications each year.
