
Apply

 - No charge to apply
 - If a student previously applied but did not enroll, entry term must be updated – instructions at www.fsw.edu/admissions
- Allow a minimum of 3-5 days for application processing





FSW DE Partners: Testing Services



- Test
- **Reading score must be college-level** in order to participate in Dual Enrollment
- Students must have a full set of scores-reading, writing, math
- 12 Hour Hold—placed on *math* and *writing scores* below college level (Students must have college-level scores by the time they reach 12 credit hours to continue in the program.)
