EMS 2656 - PARAMEDIC INTERNSHIP III - 4 CREDIT HOURS

(300 minimum contact hours)

This course involves experiences with an Advanced Life Support Provider and other related pre-hospital experiences. It provides basic and advanced life support training with an ALS agency. A minimum of three hundred (300) hours of learning experience in a work environment are required. Enrollment is restricted to those students with concurrent enrollment in the paramedic program
