General education syllabus review (GESR) name clarification: the syllabus review process involves reviewing much more than general education, and the name "geezer" is unprofessional, so the term GESR will no longer be used.

Clarification of the meaning of the word "Assessment": it is the ongoing process of

- Establishing clear, measurable expected outcomes of student learning
- Ensuring that students have sufficient opportunities to achieve those outcomes
- Systematically gathering, analyzing, and interpreting evidence to determine how well student learning matches our expectations
- Using the resulting information to understand and improve student learning

Clarification of purpose and composition: there are tasks that have to be done at the College regarding assessment. Departments are asked to identify individuals to perform these tasks. The committee can provide resources for accomplishing these tasks and bring these people together to do this work.
