#### Action item #1

Proposal: PHI 2930 Special Topics in Philosophy

**Explanation**: The proposal adds a repeatable course. By offering PHI 2930 Special Topics in Philosophy at Edison State College, we can provide that subset of our students interested in continuing their philosophical development up to three more opportunities beyond the four basic courses that we currently offer. In the past, a number of students at our college have inquired about such opportunities to continue studying philosophy while they remain with us. This Special Topics course would offer at least three important advantages: the professors can tailor their extended offerings to the interests of their committed students; should student interest warrant the subject-matter, the course can provide the professors with an opportunity to pursue research into a more specific area of philosophy than is currently offered within our four course curriculum; and by adding only one class the structure of the Special Topics course allows us a flexible way to almost double our philosophy offerings without creating a more extensive curriculum for which we might not have the demand.

**Proposal: NUR 1001C Transition to Professional Nursing** 

**Explanation:** The proposal adds a course to the AS Nursing program to accommodate the changes to the overall program. This course redistributes the credits from four other courses. The Advanced Placement Nursing Program was established to help the community of licensed practical nurses and paramedics. However, in the last few years, the trend is changing in this geographical area. Many hospitals are moving toward magnet status and strive to achieve the goal of "BSN in 10" initiative, where employers prefer ASN and bachelor prepared nurses rather than LPN's. This trend has decreased the number of LPNs in the community. Many of the LPN's prefer to work in nursing homes and physician's offices rather than going back to school to advance their degree. Because of these trends, enrollment in the advanced placement program is gradually declining. Decline in enrollment is detrimental to an educational institution. To avoid this decline in enrollment, the Edison State College Nursing faculty and staff decided to decrease the number of seats available for LPN's entering the advanced placement program and increase the seats in the generic program. Instead of conducting two different streams of nursing and utilizing the faculty resources for two separate programs, the leadership decided to conduct one program for the generic nursing and advanced placement program. To assist the LPN's into a RN program, this 3 credit hour course was developed.
