Re: Applied Music Courses

I am requesting permission to change the course descriptions for the entire list of applied music courses provided below. I am requesting this change effective Fall 2014. Each of the course descriptions for these courses contains this language:

Applied Music is individual one-on-one voice or instrumental instruction which may be arranged for Florida SouthWestern State College degree-seeking students of advanced accomplishments, especially those actively enrolled in the Florida SouthWestern State College's music program. Thirty minutes of private instruction per week equals one credit hour. It is recommended that music majors take weekly lessons in their principal instruments. Seats in applied music classes are limited. Permission of the District Dean of Humanities, Communications, and Social Sciences is required. These lessons are not intended for beginners.

- 1. Full-time music majors have first priority.
- 2. Full-time (12 hours) degree-seeking students have second priority; students who need a onecredit-hour course to "fill" their load do not qualify, nor do those who are just learning to play an instrument.
- 3. Dual enrollment students and part-time students who are likely to become full time have third priority.
- 4. Community members have fourth option on remaining seats, exclusive of those who have repeated a course more than once.

All students enrolled in applied music lessons must receive approval and certification of demonstrated advanced accomplishment by the professor, the written permission of the District Dean, and must show evidence of having enrolled in an ensemble. The written permission shall designate the criteria (1, 2, 3 or 4 as listed above) under which the student is granted approval. Students must be accommodated in

priority order; i.e., criteria one students have first priority, then criteria two students, etc. A form will be provided for this process.

Changes made to NUR 2260 and NUR 2260 (February 2014 meeting) need to be reversed for Fall 2014 and made effective Fall 2015. The changes are necessary to allow AS Nursing students currently working on their degree to complete the correct amount of credits.

The attached catalog page is effective Fall 2014 and the attached proposals for NUR 2260 and NUR 2260L are effective Fall 2015

Graduates of the Associate in Science in Nursing (ASN) program are prepared to become licensed as a Registered Nurse (RN). The role of a RN is to assess and evaluate clients and their healthcare needs, develop and implement plans of care, and document client responses to interventions. Nurses administer care to people who are ill, injured, convalescent, or disabled. Nurses counsel clients seeking healthier lifestyles.

The AS Nursing curriculum incorporates classroom instruction, laboratory, simulation education, and clinical practice in the care of diverse populations. Local health facilities are utilized for clinical practice, including community agencies, acute care institutions, long-term and ambulatory care facilities. Graduates of the program possess knowledge, values, skills, and compassion; all essential for professional nursing practice in a dynamic and rapidly changing health care environment.

#### **CURRICULUM OPTIONS:**

Florida SouthWestern State College offers several options for students to apply, enroll, and complete the Nursing AS degree program:

- Entry Curriculum, Full-Time, 4 semesters for applicants entering the nursing profession who do not meet the criteria below for acceptance into the Transition Curriculum
- Entry Curriculum, Part-Time, 5 semesters for applicants entering the nursing profession who do not meet the criteria below for acceptance into the Transition Curriculum; for applicants who would like to complete the program on a part-time basis with classes offered evening and weekend hours. The Part-Time curriculum is currently offered on the Lee Campus only.
- Transition Curriculum, Full-Time, 3 semesters for applicants who have either:
  - (1) Completed a Licensed Practical Nursing Program in Florida and hold current Florida licensure as a Licensed Practical Nurse/LPN. Applicants must enter the AS Nursing program within five years of their program completion date.

    OR
  - (2) Completed a direct patient care program in Florida, holding the related current Florida licensure: Cardiovascular Technologist/CVT, Paramedic/EMT-P, or Registered Respiratory Therapist/RRT. Applicants must enter the AS Nursing program within five years of their program completion date. These applicants **must also** hold current Florida licensure as a Certified Nurse Assistant/CNA, earned within five years of their program completion date.

### **DEGREE REQUIREMENTS and PROGRAM LENGTH:**

A total of 72 credit hours is required to complete the AS degree in Nursing. These hours include General Education Courses (23 credit hours), Program Specific Courses (7 credit hours), and Nursing Core Courses (42 credit hours). Competitive applicants will have completed most or all of their General Education and Program Specific courses before starting the Nursing Core courses.

Minimally, students must complete the following PRIOR to admissions into each curriculum:

- (1) **ENTRY -** MAC 1105 College Algebra (or higher level MAC) or STA 2023 Statistical Methods I and BSC1093C Anatomy and Physiology I with Lab
- (2) **TRANSITION** MAC 1105 College Algebra (or higher level MAC) or STA 2023 Statistical Methods I, BSC1093C Anatomy and Physiology I with Lab, BSC 1094C Anatomy and Physiology II with Lab, and ENC 1101 Composition I

Please note that BSC 1010/1010L Biology with Lab (or successful CLEP Biology testing) is required prerequisites for BSC 1093C Anatomy and Physiology, MCB 2010C Microbiology, and HUN 1201 Nutrition.

Prior to registration for the final semester of the Nursing Program, students MUST:

- (1) complete all pre-nursing and all previous semester nursing courses and
- (2) complete and document sixteen (16) hours of approved community volunteer service hours.

Each curriculum option in the AS Nursing Program is offered during various terms on Florida SouthWestern State College's three campus locations and takes various numbers of terms and calendar months to complete:

### **APPLICATION DEADLINES:**

Fall Semester Start – Application due by May 15
Spring Semester Start – Application due by October 1
\*Finalists will be notified within four weeks after application deadlines.

The Associate in Science in Nursing program has limited enrollment due to the rigorous clinical education requirements for the program. Acceptance to Florida SouthWestern State College does not imply acceptance into the AS Nursing program. Each applicant must meet specific criteria which are listed in the admission policies. The Criteria for Admission Policies are available through the School of Health Professions Nursing office on each campus. Admission information and applications are located at <a href="http://www.fsw.edu/academics/programs/asnursing">http://www.fsw.edu/academics/programs/asnursing</a>.

Acceptance to the program is based on a tally of admission points using completed pre-nursing course GPA, pre-admission testing scores, and total number of pre-nursing courses completed. Pre-admission standardized examination includes Health Education Systems, Inc. (HESI) for Entry and Transition applicants.

After notification, finalists must complete the following:

- College-approved criminal records check and drug testing at the applicant's expense.
   Note that applicant should consult Florida Board of Nursing if they have any criminal offenses, beyond minor traffic violations, which may limit RN licensure eligibility.
- Immunization and health report
- Screening for tuberculosis (TB)
- Certification in American Heart Association Basic Life Support for Healthcare Providers (CPR and AED)

### **BACCALAUREATE DEGREE OPPORTUNITY:**

Florida SouthWestern State College also offers a Bachelor of Science in Nursing (BSN) for students to advance from the AS, Nursing Degree to the BS, Nursing Degree. Graduates of the AS, Nursing Degree program with the RN credential may enroll in this degree completion program and complete remaining courses for the baccalaureate degree. > New legislation now requires that Associate in Arts (AA) degree seeking students meet foreign language competency to earn their degree. For this reason, these changes were made to the Associate in Arts catalog page.

#### Added

#### **Foreign Language Competency Requirement**

In accordance with Florida Statute 1007.25, students initially entering a Florida College System Institution in 2014-2015 and thereafter must demonstrate competency in foreign language pursuant to guidelines set in Florida Statute 1007.262.

The Foreign Language Competency Requirement may be met by:

- 2 years of the same High School Foreign Language, or
- 2 semesters of College Level Foreign Language, or
- Documented foreign language proficiency through testing (for example CLEP)

Students should check with their degree audit to verify that their foreign language requirement is met. Students who are unsure whether they have already met this requirement should meet with an academic advisor.

#### Removed

#### Foreign Language:

Students seeking admission to state universities in Florida should have completed two years of the same foreign language at the high school level or two courses (eight to ten credit hours) at the college level. Foreign language is a State University System and a Florida SouthWestern State College baccalaureate-level graduation requirement.

#### Additional Options for Pursuing a Bachelor's Degree:

- 1. Students should meet with their academic advisor to discuss degree requirements and transfer options.

When applying for admission to a state university, transfer students who have not yet completed the AA degree will be evaluated on their high school transcripts as well as their college coursework. > New legislation now requires that Associate in Arts (AA) degree seeking students meet foreign language competency to earn their degree. For this reason, these changes were made to the Associate in Arts catalog page.

#### Added

#### **Foreign Language Competency Requirement**

In accordance with Florida Statute 1007.25, students initially entering a Florida College System Institution in 2014-2015 and thereafter must demonstrate competency in foreign language pursuant to guidelines set in Florida Statute 1007.262.

The Foreign Language Competency Requirement may be met by:

- 2 years of the same High School Foreign Language, or
- 2 semesters of College Level Foreign Language (level II proficiency), or
- Documented foreign language proficiency through testing (for example, CLEP)

Students should check with their degree audit to verify that their foreign language requirement is met. Students who are unsure whether they have already met this requirement should meet with an academic advisor.

#### Foreign Language:

Students seeking admission to state universities in Florida should have completed two years of the same foreign language at the high school level or two courses (eight to ten credit hours) at

the college level. Foreign language is a State University System and a Florida SouthWestern State College baccalaureate-level graduation requirement.

#### Additional Options for Pursuing a Bachelor's Degree:

- 1. Students should meet with their academic advisor to discuss degree requirements and transfer options.
- 2. When applying for admission to a state university, transfer students who have not yet completed the AA degree will be evaluated on their high school transcripts as well as their college coursework. Transfer students without an AA degree and less than 60 hours must compete with all entering freshman applicants to the college or university.
- 3. It is strongly recommended that a student complete the AA degree prior to transferring. If this is not possible, students are encouraged to at least complete the 36 hour General Education block at their initial institution.
- 4. Students who have entered a community college with a "CPT-eligible" certificate of completion must complete the AA degree before transferring to a 4-year institution.
- 5. Students should check with the transfer services office at the college or university to which they are transferring to obtain information relating to transfer policies, financial aid opportunities, and other available assistance.
- 6. Students wishing to receive accommodations for a disability have a responsibility to inform the disability services center at the 4-year institution. A student with a disability may be eligible for a special admission review under Section 1007.265, Florida Statutes. A special admission review may apply if documentation can be provided that failure to meet an admission requirement is related to the disability and failure does not constitute a fundamental alteration in the nature of the program.
