- b. For tests that allow students scrap paper, Proctor U is supposed to have students rip up the notes in the presence of the proctor, but we should consider advising faculty to require work to be done on a whiteboard that can be erased at the conclusion of the exam to ensure the integrity of the exam.
- c. Definition of an online course is that 80% -100% of the instruction is done online. Proctored tests are a vital part of the online teaching experience.
- d. Benefits to Proctor U: high school students, distance learners, students with disabilities
