- 6. J. van Gaalen Gen Ed update
- 7. C. Seefchak asked committee to take the time to update their directory profile as it will be good to ensure that LAC members have a strong presence on FSW's webpage for those interested in reading about them.
- 8. A. Trogan updated on the LAC PD plans.
 - a. A. Trogan noted she worked with D. Ransford to plan on making changes to Assessment 101 so that it is updated and related to C-R-E-A-T-I-V-E GenEd competencies.
