 - a. Dr. McClinton and Dr. Yovanovich worked on the flowchart over the summer, an update will be provided by Dr. McClinton

- After the Academic Board, what happens?

- What do we do about a student grade related to those that cheated and earned an F when they retake the course?

- They should calculate an average previous grade, F + new grade; no way they could end up with an A if they cheated...
- We had this discussion before
- Bill Kelvin @Marius it's Deja vu all over again :P So what was the outcome in the past?
- Melanie Ulrich there is no designation for an F for cheating, so the student is offered grade forgiveness to replace the F if taken again at FSW
- Yadab Paudel Why do we have a such late withdraw policy?
- Marius Coman (from chat) "we came up with the policy.... cheating then form then dean then provost.. one does expect in any process to have 3 steps forward 1 step backward, but if it's 1 forward 2 backwards no one would call that advancement. not that comments are not very legitimate."
- Several committee members talked about the FF policy other Florida schools use for academic integrity violations

Other committee comments (from chat):

- Anne Angstrom "I think a valuable use of our time this academic year would include a focus on educating students about cheating via consistent, accessible messaging across the college."
- Vera Verga "dedicate to graduate with Integrity"
- Camille Drake-Brassfield "@Ann...yes...we need something active"
- Anne Angstrom "Get to the heart of the problem if we can't proctor work in a live ground classroom, we have to address it on the other end."
- Vera Verga "Statement they sign before any test"
- William Kelvin "positive sanction is good idea, too -- everyone who finishes without a FF gets a statement on their transcript that they did not get caught cheating? To more sharply contrast the FF recipients' records?"
- Mary Myers
 - "From USF: However, for serious violations, instructors may assign an "FF" grade. An "FF" grade is noted on your USF record, counts as an "F" for GPA purposes, and indicates academic dishonesty. It will not appear on the official transcript, but will be present on the unofficial transcript used within USF.

If you receive an "FF" grade in a course, you cannot repeat the course using the Grade Forgiveness Policy. If you try to drop the course, your registration in the course will be reinstated until the issue is resolved. Any final course grade may be changed to an "FF," "F," or other grade depending on the instructor's decision or the ultimate resolution of the Academic Integrity Review Process. This includes any determination of a violation of the Academic Integrity Regulation that is not detected until after you have dropped or completed the course or during/after the Academic Integrity Review Process."

- "It doesn't go on the official transcript though"
- William Kelvin "@Anne agreed, however they SHOULD know by now that cheating at college = bad => consequences, even if we have not adequately communicated the processes"
- Anne Angstrom "it is rampant through FLVS, which is part of the high school culture."
